– it would slow down the bleeding and slightly extend life, requiring more extensive action shortly after. Those are my few cents worth.

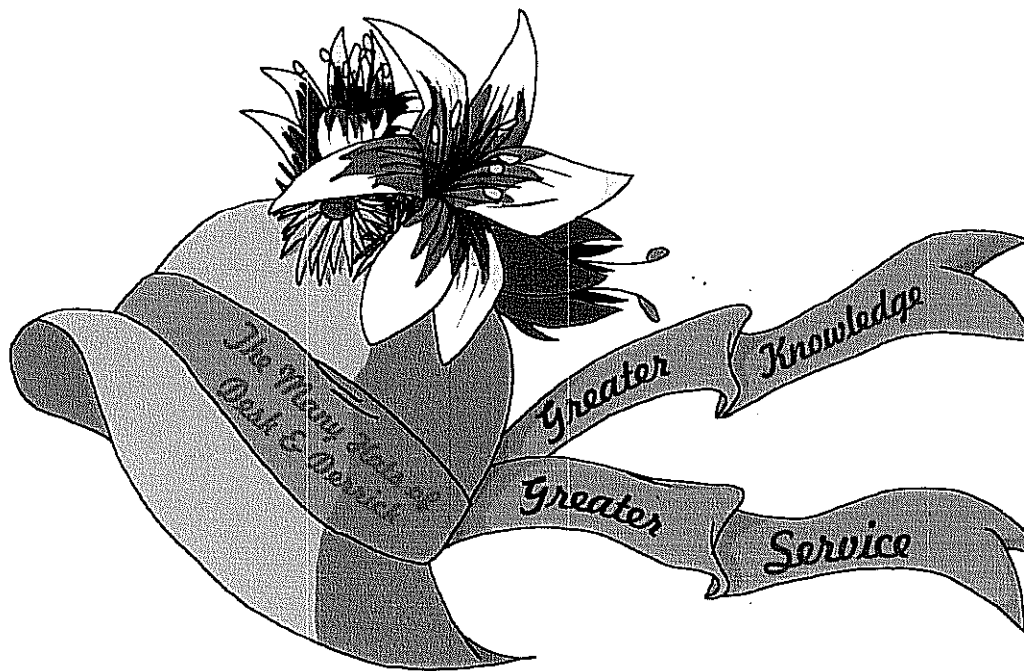

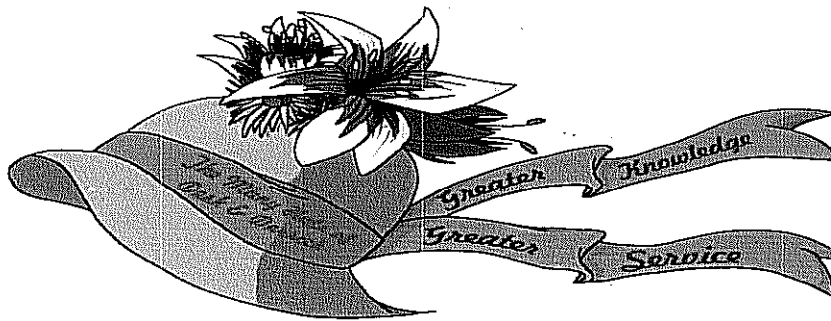

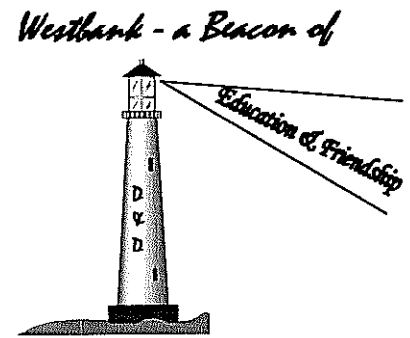

SCHOLARSHIP PROGRAM – RECAP

It was a perfect fit. Retired State Representative, Joseph Toomey, a former Vice Chancellor of Delgado Community College, was on hand to speak to us at our June Meeting, and to assist in giving out our scholarship monies.

In his message to our scholarship recipients, Mr. Toomey told them to use high school as a starting point in continuing their education. It is a necessary beginning. If you do not know what you want to do, consider a 2 year curriculum at a community college like those offered at Delgado until you know the route you want to take.

However, if you know where your interests lie, start there. Make that the starting point in your career. The more education you have, the more you will be able to take advantage of an opportunity that comes your way. If this opportunity occurs in the New Orleans area, then that is even better. Once you find your area of interest, pursue it. Do not choose a career just for the money you can make from it. You will not be happy and will not do your best.

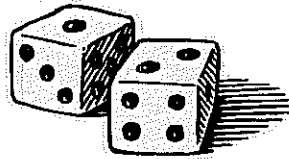
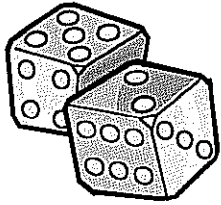
Mr. Toomey gave us a “heads up” on some hot areas of employment, areas that are always looking for good people. Consider health care or environmental services. A career in public administration is very satisfying. Tech support for a public service company is always in demand. Do not rule out not-for-profit organizations. This is a very challenging field. Do not get the idea that non-profits do not pay their employees, they do.

As a sidebar, Mr. Toomey touched on the current on-going oil spill in the Gulf. As a board member of the New Orleans Port Authority, he mentioned that there have not been any problems with ships entering the port from the Gulf. However for cruise ships leaving New Orleans and going to Mexico, the ship is held up before entering Mexican waters and an inspector arrives and examines the outside of the hull for oil. If there is none, it is allowed to continue to the port and dock. However, if oil is found, the hull must be cleaned before it will allowed in. To date, this has only happened once.

After his speech, Mr. Toomey assisted Scholarship Chairman Gaylen Guillory in handing out our scholarship monies. Seven recipients were in attendance with the other two being out of town attending orientations for their respective colleges.

As always, after our speaker’s presentation, the Westbank Club gave Mr. Toomey a certificate of appreciation and made a donation to next year’s Scholarship Fund in his name. He left with a club pin and a kiss from President Wall who has been knowing him for years. (Tell me, who does she not know!)
