



Core Samples- Not Just Rocks

A core sample is a cylindrical section of a naturally occurring substance. Most core samples are obtained by drilling with special drills into the substance, with a hollow-steel tube called a core drill. The hole made for the core sample is called the "core hole". Core samplers are varied for use in different conditions.

Core samples can be taken to test the properties of manmade materials, such as concrete, ceramics, some metals and alloys, especially the softer ones. Core samples can also be taken of living things, including human beings, especially of a person's bones for microscopic examination to help diagnose diseases.

The composition of the subject materials can vary from almost liquid to the strongest materials found in nature or technology, and the location of the subject materials can vary from on the laboratory bench to thousands of feet under the Earth's surface. The range of equipment and techniques applied to the task is great. Core samples are most often taken with their long axis oriented parallel to the axis of a borehole, or parallel to the gravity field for the gravity-driven tools. However it is also possible to take core samples from the wall of an existing borehole.

Some common techniques include:

- gravity coring, in which the core sampler is dropped into the sample, usually the bed of a water body, but essentially the same technique can also be done on soft materials on land. The sample is obtained simply by the penetration force entering the earth.
- vibracoring, in which the sampler is vibrated to allow penetration.
- drilling where a rotating annular tool backed up by a cylindrical core sample storage device is pressed against the subject materials to cut out a cylinder of the subject material.
- percussion sidewall coring uses robust cylindrical "bullets" explosively propelled into the wall of a borehole to retrieve a (relatively) small, short core sample.
- rotary sidewall coring where a miniaturized automated rotary drilling tool is applied to the side of the borehole to cut a sample similar in size to a percussion sidewall core.

For geological exploration, core samples are extremely useful. Before investing in setting up oil wells or exploring for materials like precious stones and metals, companies want to know if a site will be productive.

Coring has come to be recognized as an important source of data, and more attention and care is being provided to prevent damage to the core during transportation and analysis. The usual way to do this is to freeze the core completely using liquid nitrogen, which is cheaply sourced. In some cases, special polymers are also used to preserve and seat/cushion the core from damage.

Equally, a core sample which cannot be related to its context (where it was before it became a core sample) has lost much of its benefit. The identification of the borehole, and the position and orientation of the core in the borehole is critical, even if the borehole is in a tree trunk -dendrochronologists always try to include a bark surface in their samples so that the date of most-recent growth of the tree can be unambiguously determined.

It is common practice to "slab" core samples - cut the sample into two or more samples longitudinally - quite early in laboratory processing so that one set of samples can be archived early in the analysis sequence as a protection against errors in processing. "Slabbing" also has the benefit of preparing a flat, smooth surface for examination and testing.

Several scientific institutions maintain libraries of core samples, including ice samples, samples from trees, and so forth. These can be very useful references. Researchers may use them to compare and contrast the characteristics of various materials. Storage facilities have excellent climate control and inventory management systems to make sure samples stay in good condition while preventing sample mix-ups. They may also have investigational facilities to allow researchers to take images or withdraw sections of a core sample for analysis under microscopes, and/or engage in other activities.

Thus, core samples are more than "just rocks." They provide important information for all of us – from climate change to oil formations to our own health.

Acme Truck Line Field Trip

March 14, 2015 – it takes something really interesting to get <u>some</u> of the Westbank Club members and their guests up for a field trip on Saturday morning. Since Mr. Johnny Sanchez of Acme Truck Lines had spoken at the club meeting last summer, we knew we would be very well educated and that getting up on Saturday would be well worth the sacrifice of an extra hour in bed.

The tour began in the lovely reception room, beautifully and modernly decorated, with a HUGE wallpaper mural of some of the trucks that are leased by Acme to haul products all over the country to many oilfield sites. The reception desk sported two huge monitors for checking on visitor credentials and keeping up on the day-to-day activities via e-mail.

As we strolled through the 100,000+ square foot facility to the break room where delicious coffee and local pastries awaited us, our guides John Deris and Johnny Sanchez regaled us with stories of the company's history and current activities. The building had been the site of the local power company offices until Acme acquired it and renovated to meet its needs for the dispatch center and supporting offices.

Starting out in 1960 as a Louisiana-based intrastate oilfield hauler, the company has kept the family owned status – expanding to employee shareholding incentives – and maintained a simple formula for success: The best people combined with the best equipment and a commitment to exceptional customer service. They started out in a small portable building in Harvey, with five leased trucks and expanded over the past 50+ years to the successful service company they are today.

The company currently has a fleet of over 2,900 owner-operated trucks leased to their fleet as well as a wide variety of trailers to serve the many varied shipments, operating 24 hours/day - 365 days/year. Acme is able to meet complex customer needs, hauling 9,000 loads of oilfield, general commodities, and expedited freight shipments every week. The full service terminals guarantee personal service and quick response the customers need and deserve. Terminals are located in Alabama, Arkansas, California, Colorado, Louisiana – of course, Mississippi, New Mexico, North Dakota, Oklahoma, Pennsylvania, Texas, Utah, West Virginia, and Wyoming.

It's apparent from the rooms filled with file cabinets and the boxes of forms throughout the building and the warehouse that this is NOT a paper-less operation. All types of DOT (Department of Transportation) documents, regulatory filings, trip logs, MSDS's, and certifications are required in order to continue operations. The drivers' safety is clearly the #1 priority for Acme and their strict hiring procedures keep the quality of the drivers high enough for Acme's standards. Their safety awareness programs are clearly

effective as the company can proudly boast one of the best safety records in the trucking industry. Certificates line the walls, indicating accreditation from organizations such as IADC. The Acme U (University) class room is equipped with computers and training materials to help the drivers qualify for any state and federal requirements and maintain their accreditation, including training on how to use computers to conduct the business processes such as online/intranet trip sheets.

As we walked through the various departments, we were continually reminded of the importance of each section – payroll, accounting, dispatching, sales and marketing, regulatory and permitting, EVERY DEPARTMENT – to the overall success of the company.

Sylvia Hohmann, a 39 year member of the Westbank Club and a data specialist at Acme, was along for the field trip; we stopped at her workstation for photo opportunities and to hear more about the work done in the data management area.

After about two hours of walking from department to department, hearing about the contributions of each to the company's success, we returned to the break room for a group photo, refill on coffee, a few more questions, and thanks and presentation of certificate of appreciation to our hosts. Mr. Deris also filled our hearts with his rendition of a beautiful gospel song before we departed.


