Happy June!

Over the last couple of years, it seems our organization has been hit with some pretty hefty fines when it comes to copyright infringement of photo's.

In copyright law, there are a lot of different types of works, including paintings, photographs, illustrations, musical compositions, sound recordings, computer programs, books, poems, blog posts, movies, architectural works, plays, and so much more!

An example of the issue at hand is folks are copying pictures found on the internet and using them in newsletters, social media, etc. Unless you have purchased the copyright license or received direct approval from the owner this is copyright infringement and can be subject to hefty fines.

Is it possible to use a copyright-protected work without infringing?

Yes, in some circumstances, it is possible to use a copyright-protected work without infringing the owner's copyright. For more about this, you may wish to learn about fair use. It is important to note that your content can be removed in response to a claim of copyright infringement, even if you have...

- Given credit to the copyright owner
- Refrained from monetizing the infringing content
- Charged for a copy of the content in question
- Noticed similar content that appear elsewhere on the internet
- Purchased the content including a hard or digital copy
- Recorded the content yourself from TV, a movie theater, or the radio
- Copied the content yourself from a textbook, a movie poster or photograph
- Stated that "no copyright infringement is intended"

The best rule of thumb is to only use photos you have received direct permission to use or have purchased the license to use it. It is in your clubs' best interest to go back through your social media platforms, newsletters and anything that has been posted on a public platform and verify the content won't get you in trouble with copyright infringement laws.

ADDC FOUNDATION Regional Verbal Report 2022

In 1987 the Association of Desk and Derrick Clubs created the ADDC Foundation to assist the association, its members, and others in the energy industries to develop educational projects and programs. The funding for these projects comes from Desk and Derrick Clubs and members, companies, corporations, non-profits and interested individuals. The foundation is a non-profit, tax exempt 501(c)(3) organization, and as such, donations are tax deductible.

We are pleased to report that through your contributions to the foundation, grants have been sent to the following:

- 1. Allow \$1000 to cover costs of electricity, carpet and padding for trade shows and expos.
- 2. One regional grant was distributed this year. The Southeast Region took advantage of funding for both the meeting and certification program provided by the Foundation.
- 3. The Trustees approved up to \$1500 to underwrite the cost for the Symposium being held at this convention.

Since its founding, the ADDC Foundation has received over \$125,000 in contributions and has distributed over \$95,000 in grants and gifts to clubs, regions and other educational entities. The trustees voted to invest some of the Foundation funds into an annuity at the annual meeting last year. The invested funds did not do as well as in 2016; and thus, we met with Jackson Insurance rep this week and at our trustees' meeting on Thursday, we determined we needed to diversify this investment from strictly investing in bonds to include some mutual funds. This will give our funds more flexibility and allow for growth in mutual when bonds decline; and vice versa.

Serving as trustees for 2022 are: Christina Forth, Shelly Hildebrant, Jamie Gilmore, Audry Metford, Sheryl Minear (Secretary), Linda Rodgers (Vice Chair), Ada Weeks (Treasurer) and I am the current chairman. We are currently looking for additional trustees, as 7 of the 8 trustees are completing their terms at the end of this year. Please reach out to any of the trustees if you or someone you know would like to join the Foundation.

The Foundation is here to support worthwhile educational projects, so please send us your ideas and requests for consideration. And, as always, we thank you for your continued support.

HYDROGEN

Hydrogen is a secondary source of energy. It stores and transports energy produced from other resources (fossil fuels, water and biomass). It is a clean-burning fuel, and when combined with oxygen in a fuel cell, hydrogen produces heat and electricity with only water vapor as a by-product. Hydrogen can be made directly from fossil fuels or biomass.

It is the simplest element. Each atom of hydrogen has only one proton. Hydrogen is also the most abundant element in the universe. Hydrogen occurs naturally on earth only in compound form with other elements in liquids, gases or solids.

Natural gas is currently the primary source of hydrogen production, accounting for around 75% of the annual global dedicated hydrogen production of around 70 million tonnes. This accounts for about 6% of global natural gas use.

Hydrogen can enable renewables to provide an even greater contribution. It has the potential to help with variable output from renewables, like solar photovoltaics (PV) and wind, whose availability is not always well matched with demand. Hydrogen is one of the leading options for storing energy from renewables and looks promising to be a lowest-cost option for storing electricity over days, weeks or even months. Hydrogen and hydrogen-based fuels can transport energy from renewables over long distances – from regions with abundant solar and wind resources, such as Australia or Latin America, to energy-hungry cities thousands of kilometres away.

History

- 1839 William Grove Invents the "gas battery". the first fuel cell
- **1889** Charles Langer and Ludwig Mond develop Grove's invention and name the fuel cell
- **1950s** General Electric invents the proton exchange membrane fuel cell
- **1960s** NASA first uses fuel cells in space missions
- **1970s** The oil crisis prompts the development of alternative energy technologies
- 1980s US Navy uses fuel cells in submarines
- **1990s** Large stationary fuel cells are developed for commercial and industrial locations

1999 - Europe's first public commercial hydrogen fuel station for cars and trucks opened for business in Hamburg, Germany

2009 - Residential fuel cell micro-CHP units become commercially available in Japan. Thousands of portable fuel cell battery chargers are sol

Uses and Demand

Hydrogen use is currently dominated by industry, oil refining, ammonia production, methanol production and steel production. Hydrogen is predominately supplied using fossil fuels, so there is significant potential for emissions reductions from clean hydrogen.

Transportation

The interest in hydrogen as a transportation fuel is based on its potential for production and use in fuel cells for high efficiency, zero-emission electric vehicles. A fuel cell is two to three times more efficient than an internal combustion engine running on gasoline. Hydrogen use in vehicles is a major focus of fuel cell research and development. Hydrogen and oxygen have therefore been used as rocket fuel for decades, not because of a benefit to the environment but because the full weight of the fuel is ignited.

Several vehicle manufacturers have begun making light-duty hydrogen fuel cell electric vehicles available in select regions where there is access to hydrogen fueling stations. The global fuel cell electric vehicle (FCEV) stock reached 11,200 units at the end of 2018, with sales of around 4,000 in that year (80% more than in 2017).

China's presence in FCEVs expanded significantly in 2018, with up to 2 000 small trucks produced. However, as these vehicles wait for the corresponding refueling infrastructure, just 400 were registered for road use in 2018.

Electricity

Hydrogen fuel cells produce electricity by combining hydrogen and oxygen atoms. This combination results in an electrical current. Many different types of fuel cells are available for a wide range of applications. Small fuel cells can power laptop computers, cell phones, and military applications. Large fuel cells can provide electricity for emergency power in buildings and in remote areas that are not connected to electric power grids. Hydrogen use in vehicles is a major focus of fuel cell research and development.

Environmental Impact

Like electricity, hydrogen is an energy carrier that can be produced from various feedstocks. Although hydrogen is a clean-burning energy source, when burned it only produces electricity and water. These feedstocks and production methods should be considered when evaluating hydrogen emissions.

The greenhouse gas intensity (and other environmental impacts) of hydrogen production depends on the sources and processes through which the hydrogen is derived. It can be extracted from water using electrolysis, using power from renewable solar or wind, nuclear energy, or fossil energy. It can be extracted from renewable biomass or coal using high temperature gasification. It can be derived from renewable biogas, renewable ethanol or methanol, or fossil natural gas. Most hydrogen is derived from fossil natural gas, emitting fossil carbon dioxide as a by-product.

 - 2 tablespoons chopped fresh basil leaves
 - 6 tablespoons reduced-fat balsamic vinaigrette dressing



Steps

- Cook tortellini as directed on package, omitting salt and oil, and adding asparagus during last minute of cooking time; drain. Rinse with cold water to cool; drain.
- 2 In large bowl, toss remaining ingredients. Add tortellini and asparagus; toss gently.
