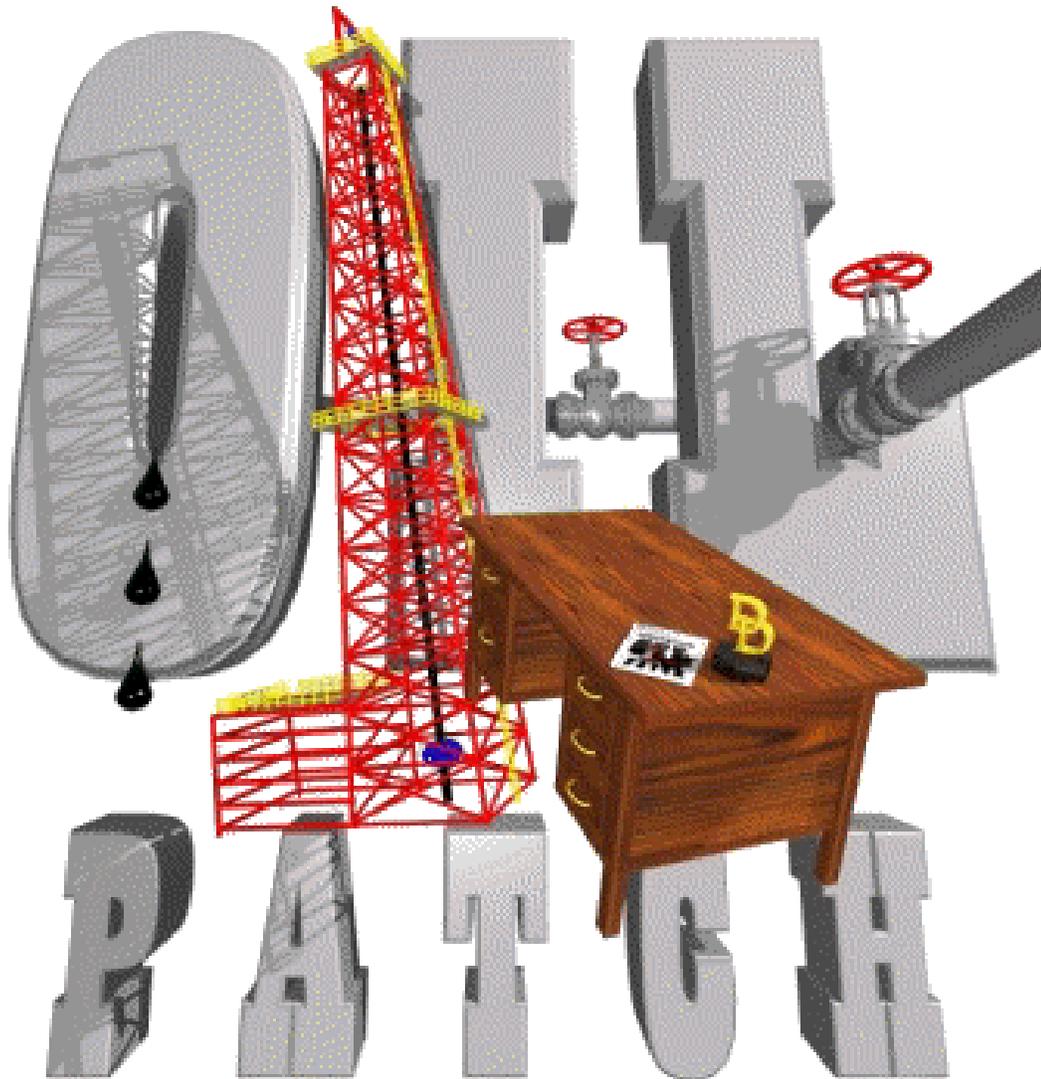



APPOMATTOX—Tapping Into Oil Over 30,000 Feet Deep

February Video Recap—by Judi Adams

Okay, I'll admit that I messed up—I planned to show the Appomattox platform on its journey from Korea to Texas under threat of a super typhoon. But, we got this one instead. It was very interesting—and provided a bit of nostalgia. I worked with Deepwater Exploration in Houston in 2010 when the Appomattox wildcat discovery was made. It was a very exciting time for Shell in the GoM and it is so rewarding to see the process of bringing it on production. It was also nice to see a few of the folks I had worked with back then and some that I worked with in Production before I retired.

So, what did it take to get this platform producing oil? It took 2-3 years from discovery to actual decision to proceed with investing in the discovery and commissioning the platform. It took over seven years and 15 million man-hours to build the largest platform Shell has ever built. And it took a crew of more than 400 spread out over four vessels to get to “first oil.”

Engineers on the Balder construction vessel were overseeing the final welding and laying of pipeline to successfully hook up with Appomattox with less than half a millimeter leeway for the fit-up. After four years of engineering design, it all came down to half a millimeter.

This was a first for the team—a 200,000 pound tree system was almost double size of any other Shell used previously. And, it must all be done safely—always SAFELY!

Using a giant crane and ROV, the team guided the tree 1 1/2 miles down; the process took about 24 hours. With laser-like precision, the team lands perfectly on the narrow target, only 1/2” wide.

Once the subsea systems are in place, the Balder, which rivals the size of Appomattox, begins the handover of the final pipeline to the Appomattox. This riser transfer requires the four vessels to perform perfectly in synchronization on the water. All goes well in this intricate process requiring many steps. The well opened and was flowing; everything worked well topsides. The reaction of high fives, handshakes, and maybe a few hugs and tears was a mixture of relief and responsibility.

Like the narrator who was onboard during this process, I got goosebumps watching the video knowing that I played a small part in Appomattox (supporting the Norphlet Team during the exploration process).



Louisiana Commits Nearly \$1.3B to Coastal Restoration, Protection Projects

The Louisiana Coastal Protection and Restoration Authority has released its Draft Fiscal Year 2023 Coastal Annual Plan, the annual spending plan for the state's coastal program. The plan guides funding to implement the 2017 Coastal Master Plan, the 50-year vision for priority coastal restoration and risk-reduction projects to restore and protect Louisiana's coast.

In response to the draft release, Restore the Mississippi River Delta – a coalition of national and local conservation groups working together to address Louisiana's land loss crisis comprised of Environmental Defense Fund, National Audubon Society, the National Wildlife Federation, Pontchartrain Conservancy and the Coalition to Restore Coastal Louisiana – released the following statement from Campaign Director Simone Maloz:

“Today's announcement marks a turning point in Louisiana's coastal program, as the state has committed to invest over \$1 billion next year to restore and protect its coast. This investment follows one of the more devastating hurricane seasons in Louisiana's history. With so many communities still rebuilding from recent storms, the urgency and importance of restoring wetlands and protecting vulnerable communities cannot be overstated.

“This Annual Plan, combined with the over \$2.5 billion also announced for Louisiana from the bipartisan Infrastructure Investment and Jobs Act led by Sen. Cassidy, means Louisiana is poised to make significant investments to achieve a safer, more equitable and climate-resilient future for its people, wildlife and economy.”

The plan includes strategies to advance several key coastal restoration projects that will benefit over 57,000 acres of vulnerable wetlands and 109 miles of levee. Key projects advancing through the plan include the River Reintroduction into Maurepas Swamp, the Mid-Barataria Sediment Diversion, the Golden Triangle Marsh Creation project, the West Shore Lake Pontchartrain risk reduction project and the Houma Navigation Canal Lock Complex project.

The state of Louisiana intends to spend \$1.28 billion on a total of 114 Coastal Master Plan projects. This will be the largest single-year funding commitment for the coastal program to date.

This dedication of funding reflects the nearly universal belief of Louisiana voters that the state should prioritize confronting its coastal land loss crisis.
