

August was a fun month with our Beach Party. Bingo and Charades following our business meeting gave us lots of laughs and a few groans.



LOGA responds to permanent injunction issued on Biden ban on new oil and gas leasing:

BATON ROUGE, LA (August 30, 2022) - Yesterday, U.S. District Court Judge Terry Doughty sided with Louisiana Attorney General Jeff Landry and 12 other states in a Louisiana-led lawsuit, issuing a permanent injunction against the Biden administration’s moratorium on new oil and gas leases on federal lands and water.


In response, LOGA President Mike Moncla issued the following statement:

“This ruling is a huge win for domestic energy production in the Gulf of Mexico. The Biden administration, from the day he was sworn in, has declared war on the oil and gas industry.

Prices at the pump have skyrocketed. Our Strategic Petroleum Reserve has been depleted. We’ve slowly become less and less energy independent. Now, we can get back to being the energy powerhouse of the world.

I’m relieved to see that our system of checks and balances saw to it that Biden has way overstepped his authority when banning these lease sales.

I’d like to thank Attorney General Jeff Landry for his diligent work in fighting for domestic production in the Gulf of Mexico.”



Recent Energy HeadlinesAugust 2022 Recap

8/31/2022 - Federal Court Partly Reverses 2018 Gulf of Mexico Lease Sales - A federal appeals court in Washington on Aug. 30 partly reversed a lower court's decision that had found that two 2018 Gulf of Mexico oil and gas lease sales by the U.S. Interior Department to energy companies were valid. The D.C. Circuit Court of Appeals rejected two arguments by environmental groups, although it agreed the agency had "sidestepped" a report that contained "some evidence" that asserted potential risks. 8/28/2022 - AAPL President: Energy Awakening - Complex path to a lower carbon footprint requires an 'all-of-the-above' approach - With all the events that have transpired over the last year — and even more so in the last six months — true illumination has been shed upon the underlying basis of our real global energy needs. While many countries around the world have set aspirational goals to achieve a lower carbon or zero carbon footprint, it has become quite apparent that achieving those goals is incredibly more complicated than originally thought or forecast. 8/15/2022 - Jamie Dimon says US energy industry is not against climate change - JPMorgan CEO Jamie Dimon believes that climate change can be addressed even if America decides to boost production of natural gas and oil. JPMorgan CEO Jamie Dimon, in a recent client call, insisted that boosting natural gas production in the United States was not at odds with the goal of reducing greenhouse gas emissions. "We should focus on climate. The problem with that is because of high oil and gas prices, the world is turning back on their coal plants. 8/7/2022 - Murphy Oil stepping up its Gulf of Mexico plans - A two-well exploration program is planned for next year. 

Chocolate Martini

Ingredients

1 oz. (30ml) Vodka

2 oz. (60ml) Amaretto liqueur

3 Scoops Vanilla Ice Cream

1 Tbsp. Dulce de Leche (either canned or homemade – your choice)

1 oz. (30ml) Chocolate Syrup (plus some to swirl with caramel syrup for rimming)

Caramel Syrup

Crushed Pecans

Hershey Chocolate Nugget



Preparation

Rim the edge of a glass with a chocolate/caramel mixture and then crushed pecans.

Drizzle chocolate syrup in the martini glass.

In a blender, combine vodka, Amaretto, chocolate syrup, dulce de leche, and vanilla ice cream

Garnish:

Hershey Chocolate Nugget – score on the bottom with a knife and slide onto the rim of the glass.

Notes

- Vanilla vodka is delicious so if you find the martini too strong, vanilla vodka will help to tone down the vodka taste and impart more vanilla flavor.
- If you do not have glass rimmers, just use small plates to put the chocolate/caramel and crushed pecans on to rim your glasses.
- Use any type of bar glass that works for you.
